CONCURRENT ENROLLMENT REQUIREMENTS

Students who are enrolled in an accredited high school and meet admission standards of the UA Cossatot (UAC) may be allowed to concurrently enroll in college courses. Requirements for concurrent enrollment include:

- 1) A high school transcript showing a cumulative GPA of at least 2.5 on a 4.0 scale.
- 2) Submit ACT, ACCUPLACER, or Aspire (9th grade test or above) scores which meet the established minimums.
- 3) Student's signature on front of form.
- 4) High school counselor, career coach, or principal's signature on front of form.
- 5) Parent or guardian's signature on front of form if student is under the age of 18.
- 6) Immunization Record showing (2) MMRs or submit documentation of reason why shots have not been taken.
- 7) Arrangements must be completed for the payment of all tuition and fees.

Students concurrently enrolled must maintain a 2.5 GPA at UAC. Failure to achieve a 2.5 GPA will result in the student not being allowed to re-enroll until she/he has graduated from high school.
